# **City Hall** annex opens on Highway 99

Mayor Nelson: 'We are changing how we serve you'

t took a while, but the Edmonds City Hall Neighborhood Office had its grand opening March 24 in the Aurora Marketplace shopping

center on Highway 99 and 238th Street SW.

Providing opening comments were Mayor Mike



Nelson, Municipal Court Judge Whitney Bennett, Police Chief Michelle Bennett, and Community Engagement Officer Tabatha Shoemake.

"For too long, our city has ignored the most diverse and most underserved part of our community," said Nelson. "No more. We see you. And we are here for you. We are changing how we serve you. Before it was about you coming to the City (downtown) government for help."

The principal uses for the space consist of the following functions:


hen will full service be restored for those relying on the Edmonds-Mukil-

## Police: Petting dog led to fatal attack on Edmonds police officer

Tyler Steffins: 'A loving father, husband, son, sibling, friend, and colleague'

Bev Eckmann felt she had to stop by the Edmonds Police station Monday for a news conference on the death of Officer Tyler Steffins, stabbed Saturday while off-duty in Las Vegas.

"He stopped by our neighborhood, as officers do on a regular basis," she said, tears in

"And we just love him. My son-in-law told me about it. Any kind of police activity, he tells me about it. He's a K-9 officer at the Port of Seattle."

Steffins, 33, was attacked by a man armed with a knife, according to the Las Vegas Metro Police Department. Steffins was taken to the University Medical

Center, where he died at 12:01 a.m. Sunday.

According to Acting Assistant Chief Josh McClure, Steffins is the first Edmonds police officer killed while either on- or off-duty.

lice Department.

Steffins is survived by his wife, 12-year-old daughter, 9-year-old son, stepmother, father, brothers, sister, friends, and loved ones.

"Our hearts go out to his family," said Edmonds Police Chief Michelle Bennett on Monday during the news conference at the Public Safety Complex.

"It's been a very difficult time for law enforcement, in general, this past week, and this has been really difficult for our staff."

Said Edmonds Mayor Mike Nelson: "I can't think of anything more horrible than talking about a City employee, a police officer, a dad. His two kids are very close in age to my children.

'And my heart goes out to our City employees, our police

officers, and Tyler's coworkers, who are also his friends. They're really going to need your support, as well as his family and his loved ones, during this really tragic time."

Acting Assistant Police Chief Josh McClure became emotional when remembering Steffins.

"Tyler was off duty at the time, just enjoying Las Vegas as anyone else would. Our staff had been pulled in many different directions since Friday, with the tragic loss of the Everett police officer while he was on duty. So many of our detectives and peer support personnel have been helping Everett, all while law enforcement in the

region was dealing with the loss of the Pierce County deputy." Everett Police Officer Dan Rocha, 41, was killed Friday, March 25, shot in the parking lot of a Starbucks. Pierce County Sheriff's Deputy Dom Calata, 35, was killed Wednesday, March 16, while he and another deputy served a warrant in Spanaway.

Calata was shot in the head. Sgt. Rich Scanliffe was shot in the leg, and is recovering.

### Gloria Hoppler: 1931-2022

Gloria Ann Youngren Hoppler joined her Lord on March 22, 2022, in Olympia, Washington. She was 90 years old. A graveside service will be held for Gloria on Thursday, March 31 at 1:30 pm at the Edmonds Cemetery and Columbarium at 820 15th St. S.W. in Edmonds.

Gloria was born to Carl Youngren and Agnes Bell (Montgomery) Youngren on Oct. 25, 1931, in DeKalb, Illinois, but lived over 50 years in Western Washington, most of that time in Edmonds. She had one sister, Judith, who preceded

Gloria graduated from Joliet High School in 1949. She studied nursing at the University of Illinois, Cook County School of Nursing. Shortly after graduation she married Jarvis "Bud" Hoppler, her high school sweetheart. They had three children: Jann Marie in 1953, Craig Jarvis in 1956, and Wesley Carl in 1961.

Bud's career led the family to reside in many communities, Fort Wayne, Indiana; Anaheim, California; Beaverton, Oregon; Northfield, Minnesota; and from 1967-1969, Camberley, Surrey, England.

In 1969, the family relocated to Lynnwood. Bud and Gloria divorced in 1974. Gloria moved to a house near downtown Edmonds.

Gloria returned to full-time nursing. To refresh her skills, she attended Coronary Care Nurse's Training at Cornell University Medical School in New York City. She worked at Harborview Hospital in Critical Care for many years.

In 1977, she was the first nurse at Harborview to become a Critical Care Registered Nurse (CCRN). She was a member of the staff of Stevens Hospital (now Swedish Edmonds Campus) for over 18 years, finally retiring at 72.

Gloria was honored by the American Association of Critical Care Nurses for over 30 years of continuous certification as a CCRN, one of only 35 nurses nationwide with that

Gloria was a confident and inspiring presence in any room. She had a big personality and a vision for every project she was a part of. She was always ready to take on a new challenge or hobby. Over her life, she became an integral part of many communities, and always believed in contributing to any group she joined.

Family was very important to Gloria. She nursed her mother and sister

before their deaths and brought her father to live near her in Snohomish County when he was no longer able to live in his house in Illinois. Her deep love for her children and grandchildren will continue to be felt long after her

Gloria was a life-long Lutheran, who held a strong faith in Jesus and was very involved in her church. After her retirement, she was active in Neighbors in Need, an outreach program of Trinity Lutheran church in Lynnwood, where she was a member of the congregation for many years.

Gloria had a lovely voice, and always sang in church and community choirs. She was a long-time member of the SnoKing Community Chorale. She was registrar and rehearsal manager of the Chorale for the first eight years

While in Edmonds, she always had two dogs, short and long-haired collies, who were shown in competitions. She said that while some were champions, all were her good

Gloria is survived by her three children: Jann and her husband, Bruce Treichler, of Olympia; Craig and his wife, Susan, of Federal Way, and Wesley of Ballard; and by her two grandchildren, Emily Brockway Hoppler Treichler of San Diego; and Kristina Elese Hoppler of Federal Way.

Recently hired Edmonds Assistant Police Chief Rod Sniffen knew both Rocha and Steffins. He was hired from the Everett Police Department.

"It's an incredibly difficult time, coming from the police family in Everett just two weeks ago and having to deal with that tragedy," he said. "Now coming here to Edmonds to my new family and another tragedy happens.


"It's very trying. It's not easy. I think it's important that both agencies, their families come together, to be there for each other. And I can't say enough good things about the City of Edmonds and what they've done to support me."

#### Verbal altercation

Las Vegas officers were alerted to a stabbing at about 9:39 p.m. Saturday, March 26, on a pedestrian bridge near the 3900 block of Las Vegas Boulevard South and Tropicana Avenue, which connects the New York-New York and MGM Grand hotels.

According to the Las Vegas Review-Journal (bit.ly/36TGr8G), which received a copy of the police report, police said they located a man in the area of the bridge named Dean Cattorini, who said he was on a pedestrian bridge near the Excalibur a day earlier when Steffins approached and "grabbed his dogs (sic) face aggressively, and it upset Dean."

The next day, just prior to the stabbing, Cattorini said Steffins approached him and

his dogs on the pedestrian bridge again as a man named Freddy Allen was standing nearby, the Review-Journal reported.

"Dean and Freddy (Allen) were ap-

proached by Tyler, who stopped to pet the dogs," police wrote in the report. "Dean asked Tyler not to be rough with them." Cattorini said Steffins petted the dogs ag-

gressively again, and Steffins and Cattorini started to quarrel, according to the newspaper. Steffins then said to Cattorini, "get a job."

Allen, standing nearby with his hands be-

hind his back, suddenly lunged at Steffins, according to the report.

The Review-Journal reported that Cattorini said he thought Allen simply shoved Steffins, but after Allen ran away, Steffins said. "I think he just stabbed me."

"Tyler took off his shirt and a few seconds later he collapsed on the ground," the report said, which added that police later found a hunting knife with a 6-inch fixed blade suspected in the attack.

Allen, 58, has a record of run-ins with Las Vegas police, the Review-Journal reported, including a previous stabbing in which he served three months in jail.

Allen was taken to the Clark County Detention Center and booked for murder with a deadly weapon. Allen was scheduled to appear in Las Vegas Court Monday morning, but his "disruptive behavior" canceled the appearance, according to the Review-Journal.

#### Hired in 2018

Tyler Steffins was hired in 2018. He was a veteran of the United States Marine Corps (corporal, 2007-2011), with recognition for his service during Operation Enduring Freedom

"I was fortunate to be part of the hiring team that brought him in with three other fantastic officers who graduated the academy in March of 2019," McClure said.

"He was No. 1 in his class, and a proud United States Marine. And don't let anyone tell you otherwise. Because all Marines are proud, right? Tyler completed field training without a hiccup and was working towards day-shift-night-shift patrol at various times since completing field training.

"He was a loving father, husband, son, sibling, friend, and colleague. He's incredibly missed here in our building already, just the last 12 hours or so, and I can only imagine what his family is going through as well."

A statement from the Snohomish County Prosecuting Attorney's Office recognized the heavy sorrow felt by Steffins' family and

loved ones, his law enforcement colleagues, and the entire Edmonds community.

"His tragic and untimely death comes as a shock to us all," said Snohomish County Prosecutor Adam Cornell, who lives in Edmonds. "We will be forever grateful for his immense and selfless commitment to keeping our community safe and for all his fine work."

Snohomish County Executive Dave Somers also released a statement: "One of Edmonds' finest was taken from our community much too soon. Our prayers and deepest condolences go out to Officer Tyler Steffins' family, his colleagues in the Edmonds Police Department, and all who are impacted by this unimaginable tragedy.

"Our region has seen too much loss of life over the last few weeks, and we must never lose sight of these profound sacrifices. Police officers choose a career in law enforcement because they want to serve the community, even though that service comes with extreme risk. We offer any support Edmonds needs in this time of mourning."

#### A chill individual

McClure said Steffins was liked by all, and was used in several recruiting efforts, including one where he had a handshake with a citizen walking downtown.

"Tyler was a very chill individual. He spoke with an even, steady tone. He didn't say much, but when he did it was usually funny."

McClure said he couldn't speak for his colleagues, but he said Steffins' death has affected him. That was evident at the news conference.

"I have two daughters that ask why we still have jobs that seem a little chaotic. It's just what we do. When you become part of this profession, you realize this is what I was meant to do. When I was sitting at home on Friday, enjoying my day off and learning about the tragedy in Everett, all I wanted to

do was go to work.

"People just want to be part of the great thing we have here. Because they know they've got a great group of people to rely on."

#### **Growing memorial**

On Monday, the Edmonds Police created a memorial for Officer Steffins located in front of the south entrance to the Public Safety Complex.

Among those placing flowers on Mondays was Pauline Bucklin, who has lived in Edmonds for 71 years.

She is the wife of Mark Bucklin, a retired defense attorney who worked with the Edmonds police union.

"I just feel terrible about what is happening to our police officers," said Bucklin, who placed a bouquet of daffodils and a planter with tulips.

"I don't understand how people can be so cruel, and what's happening in our world. I feel like the lunatics are running the asylum"

#### Health insurance for the family

On Wednesday, The City of Edmonds said that it "recognizes that in the event of an employee's death, the surviving family members will be impacted by the loss of health insurance coverage and additional costs of COBRA required to continue such coverage."

In order to assist the surviving family members with this transition, the City enacted the following policy: When an active employee dies, the surviving spouse and surviving dependents who are enrolled in the employee's active health insurance (medical, dental, vision) at the time of the employee's death, will receive up to three months of continuation of health coverage (COBRA) paid for by the City.

In order to receive this benefit from the City, the surviving spouse and dependents must enroll in COBRA in compliance with COBRA regulations and per the City's COBRA administrator requirements.

The City will pay for the cost of COBRA directly to the COBRA administrator.
