# Late Census info complicates redistricting

NEWPORT - The fact that population data from the 2020 census won't be available until the end of September has made it more difficult for state and local authorities to redistrict voting districts, according to a presentation given to Northeast Washington Counties during a meeting in Newport Wednesday, March 31.

NEWC is made up of county commissioners from Okanogan, Ferry, Stevens and Pend Oreille counties. Stevens County commissioners Wes McCart and Mark Burrows joined Pend Oreille County commissioners Mike Manus, John Gentle and Brian Smiley in person in the Pend Oreille County commissioners' room. The other commissioners attended remotely.

Pend Oreille County Auditor Marianne Nichols presented a PowerPoint presentation from Pierce County

# Pride parade draws attention to Fox murder

NEWPORT - Last Saturday marked the first gay pride parade in the Pend Oreille Valley a couple hundred people marched through Newport and crossed state lines into Oldtown in honor of murder victim Jason Fox. Fox, a former Newport resident whose body was discovered in a shallow grave in October 2020, would have turned 20 years old on April 3. Those who gathered in Newport City Park Saturday afternoon maintain that Fox's death is a hate crime and that he was killed because he was gay.

Four people have been charged with Fox's murder and are currently in custody, including Matthew Raddatz-Freeman, 28, Kevin Belding, 24, Claude Merritt, 25, and Riley Hillestad, 26.

"Jason loved people and all he wanted was love and acceptance," event coorganizer Dustin Jolly said. "He would

be alive today if he wasn't gay in rural America."

The Pend Oreille County Sheriff's Office has maintained that they are still investigating the motive for Fox's murder. and while a hate crime has not been ruled out, neither is it confirmed. In order to convict a defendant of a hate crime, the prosecutor must prove beyond a reasonable doubt that the defendant committed the crime because of the victim's race or sexual orientation or for some other

prohibited reason.

Fox's mother, Pepper Fox, made a video last month on the social media platform TikTok that went viral, attracting more than 10 million views.

"He (Jason) was the most beautiful thing I have ever seen," Pepper Fox said at the pride gathering. "There was one time where we were in the car together and he was singing that Adam Levine

Prosecuting attorney Lori Smith presented witnesses who testified that Kelly attacked them and took the truck as well as photographs of the man who testified Kelly beat him, taken by law enforcement showing contusions on the man's face.

Six witnesses testified, including the co-owner of the truck. who testified via Zoom from Colorado. Kelly did not testify.

### Prescribed burns planned in Washington, Idaho

OLYMPIA - Annual prescribed burning on state and federal land in Washington and Idaho are planned for April. Prescribed burning is a forest management practice that intentionally burns off accumulations of vegetation and logging debris. The fires are intended to promote forest health and prevent more intense wildfires by reducing fuel.

In Washington, WDFW plans a prescribed burn in the Rustlers Gulch area, on 523 acres about 15 miles southwest of Newport.

Prescribed burns are also planned for the Colville National Forest.

In Idaho, multiple prescribed burns are planned. Prescribed burning is part of each Ranger District's annual natural resource management program.

In both states, fire managers evaluate weather and fuels to determine when burning can be safely conducted.

that outlined some of the problems the late Census data will create. Every 10 years voting district boundaries are set based on the Census data. Voting districts are supposed to be roughly equal in population.

Ordinarily, local jurisdictions receive Census date from the state Redistricting Commission in the spring and have eight months to redistrict. That gives time for the redistricting to be completed so that people can see what districts they live in and consider whether they want to run for office.

The census data was originally scheduled to be available to the state July 31, 2021, with counties and other local jurisdic-

tions receiving the data within 45 days after the state receives it. Local jurisdictions need time to receive local input and approve the redistricting.

Election filings take place the following May. Since Pend Oreille County Commissioner District 2, the seat held by Mike Manus, is up for election in 2022, that's important here, Nichols said. People may want to run and will need to know if they live in the district.

Pend Oreille County has 27 precincts that can have no more than 1,500 people in each district and Pend Oreille County doesn't have close to that many people in any one precinct, Nichols said. Precincts are the smallest voting district.

That's quite a bit fewer

than Okanogan County, which as 248 precincts. Still, Nichols said there are 67 different ballot combinations that can occur in Pend Oreille County between all the jurisdictions such as fire districts, school districts and other districts with elections. Defining district boundaries takes time.

County commissioners have the authority to set voting district boundaries, based on population, Nichols said.

She said that in Pend Oreille County it seems probable that Commissioner District 3, in the north county will continue to extend south. There is a precinct that encompasses both sides of the Pend Oreille River that could be changed, she said.

In addition, it appears that the 5th Congressional, represented by Rep. Cathy McMorris Rodgers may move west when the census data comes in.

According to the state constitution, Feb. 8, 2022 is the latest day the state Legislature can amend the Washington State Redistricting Commission's congressional and legislative district boundaries and May 2 is the last date county commissioners can adopt precinct boundary changes. Candidates must file for office shortly after that in May for the 2022 election cycle.
